Any candidacy for the position of director of the *Ordre des ingénieurs du Québec* must be supported by the signature of at least 10 members of the Order whose professional domicile is in the electoral region covered by the position (Part 2).

Only members whose right to engage in professional activities is not restricted or suspended as of **4 p.m. on July 4th, 2020**, may be candidates in a given region.

The completed nomination form (Parts 1 & 2) and the following documents must be received by the **Secretary of the OIQ** at the address indicated below :

- A photograph taken in the last 5 years (JPEG format)
- The candidate's statement (not to exceed 400 words - the English translation will not be included in the word count)
- A brief curriculum vitae
- A sworn declaration (Part 3)
